A. ACTION (RESOLUTION) TO ESTABLISH A COMMITTED ACCOUNT FOR THE APPROPRIATION OF A CHARITABLE CONTRIBUTION, DEFINE HOW IT WILL BE EXPENDED AND AMEND THE FISCAL YEAR 2017-2018 BUDGET ACCORDINLY: The Acting District Manager presented a Resolution for adoption by the Board of Directors that would approve the establishment of a committed account for the appropriation of the charitable contribution accepted March 8th 2018 and adjust the Fiscal Year 2017-2018 Budget accordingly.
